1. SCOPE OF SERVICES

2. PAYMENT TERMS

A non-refundable deposit of 50% is due before work begins. The remaining balance is due in full before final files are delivered. All payments are made via Zelle to the contact on file.

3. REVISIONS

Each service includes one round of revisions. Revision requests must be submitted within 14 days of file delivery. Additional revisions beyond the included round are billed at the full individual rate for that service.

4. TIMELINE

Estimated timelines will be provided at project kickoff. Midnight Forge is not liable for delays caused by late client submissions, incomplete materials, or client unresponsiveness.

5. CANCELLATION

If the client cancels after work has begun, the deposit is forfeited. If Midnight Forge cancels, a full refund of any deposit paid will be issued within 7 business days.

6. OWNERSHIP
